Important Instructions for All Manufacturers & Permittees of Frost-Free Refrigerators (FFR), Direct Cool Refrigerators (DCR), and Ceiling Fans

All manufacturers and permittees of Frost-Free Refrigerators (FFR), Direct Cool Refrigerators (DCR), and Ceiling Fans registered under the S&L (Standards & Labeling) program of BEE, under the mandatory phase are hereby informed of the following:

1. Revised Star Rating Table & Validity Period

The energy performance standards for the following appliances have been revised. The new star rating tables are valid for a period of three years, effective from **1st January 2026 to 31st December 2028**, in accordance with the notifications mentioned below:

S. No	Appliance	Notification Reference
1	Frost Free Refrigerator (FFR) / Direct Cool Refrigerator (DCR)	S.O. 4490(E) dated 11 th Oct, 2024
2	Ceiling fan	S.O. 3471(E) dated 14 th Aug, 2024

2. Expiry of Existing Star Labels

The revised standards will come into force on 1st January 2026. Consequently, all active star labels for these appliances under the current standards will automatically expire on 31st December 2025.

3. Process for Continuing Existing Models

Manufacturers/Permittees wishing to continue their BEE-approved models under the new standards must apply for the "Continuation Option" (degradation option).

- Deadline for Application:** All applications must be submitted by 5th December 2025.
- Application Fee:** A fee of ₹ 1,000/- is applicable for the continuation of existing model.
- Portal Availability:** The continuation link ("Change of label to New label") will be available on the S&L portal starting 24th September 2025 at 10:00 Hrs.

4. Application Procedure: Change of Label to New Label

To apply for continuation, please follow these steps:

- Log in to your portal account.
- Your list of active/approved models will be displayed.
- Click the "Change of label to New label" link visible against each applicable model.
- Complete the required details in the form.
- Upload the following documents:

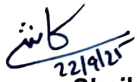
- a. The original BEE approval letter for the model along with latest test report of the model if the earlier approval letter is more than 3-years old.
- b. A new sample label for the model conforming to the revised standards and validity period.
- vi. Submit the application.

Note: All submitted documents must be sealed and signed by an authorized signatory.

5. New Model Registrations

For the registration of new models under the revised standards, an application fee of ₹ 2,000/- shall be applicable.

Manufacturers/permittees are requested to comply with this Advisory in a timely manner to avoid any disruption in model validity under the S&L program.
